The club president has to sign the scorebook application and it must be sent to the DVG office. The club president has to verify that the AKC papers list the same information as the application for a scorebook, and that this is the correct dog. Without a DVG scorebook the trial judge cannot allow the handler to enter a trial.

The data given will be used to issue the scorebook and for registration. Pedigrees issued by an organization that is not a VDH member are not acceptable. In such cases, only give the dog's name on the application, without the breedbook registration number. If the pedigree is questionable as VDH papers, please send a copy with the application to the DVG office for examination (by registered mail, please).
